3. Proposed revision of COCC’s general education outcomes (Annemarie Hamlin)
Annemarie asks that everyone do their own analysis of whether the proposed COCC outcomes are substantially similar to the original outcomes, as HECC requested that we do. Please see the file “General Education Outcomes old and new.”

Two notes:

- **Science:** We received feedback from PSU on the science outcomes: “The only change I would be concerned about would be the changes for Science, which are “Science: Evaluate a hypothesis using qualitative or quantitative data.”. I recognize that COCC was splitting Computer Science from Science in making that statement, but I’m concerned it doesn’t cover what is already in the state outcomes well enough.”
- **Information Literacy:** In 2019, the statewide library group proposed changes to the information literacy outcomes, and I have included those updates here. However, we have yet to confirm whether these changes were accepted.

Another note: the state (JBAC? HECC?) is also concerned that any revised outcomes “follow the spirit” of the criteria they have which expand on the outcomes. Please review

the file "Appendix E – Outcomes and Criteria for Transferable General Education Courses in Oregon."
