Introduction: This agreement details the applicability of courses from the Central Oregon Community College Associate of Applied Science in Health Information Technology degree to the Bachelor of Science in Health Information Management degree in the UC College of Allied Health Sciences. Students who complete the Associate of Applied Science Health Information Technology degree at Central Oregon Community College have satisfied the UC General Education requirements.

Articulation Overview: Graduates from Central Oregon Community College who have followed the prescribed program and are accepted into the UC College of Allied Health Sciences will be granted junior status in the Bachelor of Science in Health Information Management program. All degree requirements are completed online.

Admission Criteria: Applications are accepted continuously throughout the year. A complete application requires the following:

- Completed online University of Cincinnati application
- Completed BS HIM program application
- Official transcripts of all colleges/universities attended
- Associate of Science or Associate of Applied Science degree in Health Information Management from a CAHIIM-accredited program. Degree must include sufficient general education courses (i.e. English)
- Registered Health Information Technician (RHIT); graduates of an associate degree program have six (6) months to successfully complete the RHIT examination
- Submit current AHIMA membership card or proof of maintenance of RHIT certification
- Resume of professional and educational background

Minimum GPA: 2.6/4.0

Admission Period: Central Oregon Community College students must be admitted to the UC College Allied Health Sciences of during the duration of this agreement, i.e. between May 2018 and May 2021.

Agreement End Date: May 2021





