

This agreement is based on the evaluation of the rigor and content of COCC's coursework and OSU's Baccalaureate Core and College of Business degree requirements.


Note: Students may only transfer 124 lower-division credits towards an Oregon State University Baccalaureate degree. This agreement is subject to yearly re-evaluation by both schools for continuance. 



Electives and Additional Comments:

- This agreement specifies 87-91 credit hours. Since the Associate of Science direct transfer degree program requires a minimum of 93 (and a maximum of 124) credit hours, the difference will be in the form of electives from the list of approved and articulated courses between COCC and OSU Cascades. Students should work with their advisor to select the most applicable elective courses.
- Note: No more than 12 professional/technical credit hours may be used.
- Professional School Applications: Students will initially be accepted as Pre-Business major. Students will apply for acceptance into the professional school as they enter their junior year after they have completed their freshman and sophomore requirements. Transfer grades will be considered. Transfer students should discuss the application process with an advisor beforehand.
- Accounting Application (for students who transfer to OSU Corvallis only): OSU has established a new B.S. in Accountancy degree program. Starting Fall Term 2006, all students who wish to complete the Accountancy degree program will need to apply and be accepted. Transfer grades will be considered. Transfer students should discuss the application process with an advisor beforehand.
- B.A. Versus B.S. Degree
 - Bachelor of Arts Degree:
Students who desire to earn a Bachelor of Arts degree in Business Administration will need to:
 - A. Demonstrate proficiency through the second year of a foreign language (foreign language proficiency is defined as completing the 213-level of that language with a C or better or getting a signed letter by the OSU Foreign Language and Literatures Department that states they have determined the student has that level of proficiency without needing course work), AND

- B. Demonstrate cultural awareness by either:
1. Completing 6 credits of upper division course work focusing on the culture of regions that commonly use the foreign language in which the student is proficient, OR
 2. Successfully complete a study abroad, global intern, or research experience of at least 10 weeks in a non-English speaking foreign country while enrolled at OSU. This experience must be clearly documented for audit purposes.
- o **Bachelor of Science Degree:** Students completing all the requirements for the Business Administration major will automatically satisfy requirements for a Bachelor of Science degree.
